Greetings TCROA Members!

2021 Maintenance Fees Reminder: At the August 29, 2020 Board meeting, the Board of Directors elected to increase the annual maintenance fee \$25 to cover unavoidable expenditure increases and reductions to income. Therefore, the 2021 Maintenance fee is \$600 per interval.

Bonus Time – At the March 2021 meeting, the Board voted to increase the cost of “Bonus Time” due to the recent increase in annual maintenance fees. The new bonus time rates are as follows: Nightly Rate: **\$125** (Three night minimum) - Weekly Rate: **\$600** - You can submit a request for ‘Bonus Time’ via the website by clicking on the “Reservations” link in the upper right. Reservations can be made 60 days or less prior to arrival pending availability.

Beach Passes - The TCROA Board and QM Corporation continue to have discussion with the Incline Village General Improvement District (IVGID) regarding the discontinuance of the beach pass program and the impact it has to providing beach access to Tahoe Chaparral owners. As we have more information to share on this subject, we will do so. Please know we are diplomatically engaged with IVGID staff in representing our owners and hope to come back to you with a positive resolution to this matter.

Local News: The North Lake Tahoe Fire Protection District’s Fuels Management Division has been conducting burns this season burning 247 acres of piles over the 2020/2021 winter, due to favorable weather conditions. NLTFPD burned all of the piles that were cured and ready to burn for this year. Most of the piles were located on USFS and Incline Village General Improvement District land, with some additional units that were on private property.

Online Payment Option: QM Corporation is providing owners with new online payment options, via QuickBooks Online. If QM Corporation has a valid email address on file for you, your annual invoice will be sent electronically. The email will contain the amount due, a link to view the invoice, and online payment via credit card, debit card or bank transfer. QuickBooks Online uses the latest security protocols to ensure your online safety. You will continue to have the option to pay via check. If you wish to use the online payment method, please make sure QM Corporation has your current email address. You may contact them at 775-355-4040 or 800-821-4912.

Owner Sales Incentive: Want a discount on your annual maintenance dues? At the October 2017 Annual Meeting, the Board approved a sales incentive program for homeowners to receive a 50% credit on their next Annual Maintenance Fee for each referral resulting in the sale of an Association owned unit. Two sales will cover an entire Annual Maintenance Fee for one interval. Exchanging Weeks: Occasionally, the Board receives several requests from owners to either buy-back their week/interval OR swap/exchange their week/interval with another week owned by the association. Please note: The Board does not “purchase” intervals (weeks) from owners who no longer desire to own a particular week. Owners can try to sell or trade any unwanted intervals in various means, such as posting in the newsletter, offering to family/friends, etc.

Club QM: Just a reminder you may receive marketing calls from QM Corporation regarding their Club QM offerings. It is up to you to decide whether buying into Club QM is advantageous to you.

Ads in Newsletter - If you are unable to use your week, don’t forget you can advertise in our quarterly newsletters to rent (or swap) your week. To place an “ad” in the newsletter, contact Sophia Terry (sophia.terry@qmcorp.com or 775-355-4040 Ext. 3802).

Key Cards: When you check out, please remember to return your key cards (room keys) to the slotted box in the check-in office. This way, we can reuse/re-key the cards which saves money (and helps keep annual maintenance dues low).

Aerobeds – If you are in the need of an Aerobed (portable, blow-up mattress), please make sure to let QM know when you confirm your reservation and they can ensure the Aerobed is in your unit when you arrive. If you forget, you can advise them upon check-in, but it will delay you receiving a mattress.

Parking

As a reminder, when enjoying family and friends as guests during our vacations, please consider that **parking is restricted to assigned unit spaces only**. If you would like extra parking, please contact the Front Desk staff and inquire about any possible open spaces. Please note, any potential openings are made available on a first-come, first-served basis. If you choose to park vehicles in areas off of Tahoe Chaparral property, be advised that you do so at your own risk and there is a possibility of your vehicle being towed. Thank you for your cooperation.

Association Owned Weeks -There still are some Association-owned weeks recovered from foreclosures which we do not collect annual maintenance fees. Obviously, the more units we sell, the more income is generated to maintain our units, thereby keeping our annual maintenance fee very affordable compared to other timeshares.
