Greetings TCROA Members!

I hope you enjoyed the summer at Lake Tahoe and everything went smoothly. The Board met on August 24th to go over the Budget for the coming year. The good news is we will not have a huge hike like last year, however we do have to increase the annual fees by \$75 per unit due to the rising costs to property insurance.

The Board received a list of damaged furnishings within the units, adding up to quite a major expense. In light of these necessary replacements, the Board approved a motion for one more special assessment in 2025 for a one-time amount of \$100 per unit. This money will be used to completely replace all the accessories in the units which would include lamps, bar stools, coffee tables etc. A lot of these items have aged considerably and would be noticed if you have recently been up to the units.

Following the August quarterly meeting, the Board held an executive meeting to discuss items in the CC&R's. It is encouraged for all members to read their CC&R's as there are some very important articles that will be affecting all our members in the near future. The term of the HOA is scheduled for termination or extension per CC&R Article 12 and it needs to be discussed by the owners.

Given the nature of those articles, we encourage everyone who can possibly attend the annual meeting on October 19th to come and learn firsthand the importance of what this means to the membership.

Board of Directors Vacancy: Tahoe Chaparral Board has been working diligently to fill the vacant Board of Directors seat. The meetings are held in Sparks, Nevada and there are usually 4 meetings dates per year; including our annual owner's meeting in October.
